NOTICE OF PUBLIC HEARING MINOR VARIANCE

Pursuant to Section 45(5) of The Planning Act

ZONING:

Estate Residential (ER) Zone by the Town of Aurora Zoning By-law 6000-17

PURPOSE:

The Owner has submitted a Minor Variance Application to allow the construction of a two storey detached dwelling and accessory structure within the Oak Ridges Moraine and to allow an increase in building height for an accessory structure (cabana).

BY-LAW

REQUIREMENT:

- 1) Section 34.4.1(ii) of Zoning By-law states net developable area of site that has impervious surfaces shall not exceed 15% of total site area within a Category 1 Landform Conservation Area.
- 2) Section 34.4.1(i) of Zoning By-law states net developable area of site that is disturbed shall not exceed 25% of total site area within Category 1 Landform Conservation Area.
- 3) Section 6.2.3 of Zoning By-law requires maximum building height of 3.5 metres for an accessory structure.

PROPOSAL:

- 1) MV-2017-38A: The Applicant is proposing an impervious area of 16.5% to construct two storey detached dwelling and accessory structure; thus requiring Variance of 1.5%.
- 2) MV-2017-38B: The Applicant is proposing disturbed area of 31.3% for construction of two storey detached dwelling with accessory structure; thus requiring Variance of 6.3%.
- 3) MV-2017-38C: The Applicant is proposing to construct an accessory structure (cabana) with a building height of 5.4 metres; thus requiring Variance of 1.9 metres.
