BY-LAW

REQUIREMENT:

 Section 24.278.1.2 of the Zoning By-law allows fitness centre provided that no part of building in which use is located is used for any commercial self-storage facility, warehouse, industrial use, motor vehicle body shop, or motor vehicle repair garage.

PROPOSAL:

 The Applicant is proposing a fitness centre (dance school) in a building (Units 3 & 4 of subject property) that contains uses such as industrial and warehouses; thus requiring Variance from this provision of the Bylaw.
