### Financial Support for the Aurora Sports Hall of Fame

Donating Funds through the Cornerstone Committee helps the Aurora Sports Hall of Fame do a number of things essential to success:

- 1. Support Inductees and families at the event and subsequent events.
- 2. Ensures that all important celebration plaques and awards are supported for use in the Aurora Sports Hall of Fame and for the Inductees.
- 3. Maintains the public presence of the Aurora Sports Hall of Fame through the Web-Site and the Hall itself, providing funds to maintain the assets of the Aurora Sports Hall of Fame.

The Cornerstone Committee has identified a number of strategies and has implemented them in the Community to generate funds. One such strategy is to ask for consideration as a recipient of charity golf tournaments. Another important funding strategy is to campaign locally for "Cornerstone Donors". These donors are those who advance funds because they:

- 1. identify with sport in Aurora because of their commercial, economic or employment involvement.
- 2. value the socio-economic impact that sport plays in the Community.

Presently, there is a critical need for funding and Cornerstone Donors are sought to help sustain the Aurora Sports Hall of Fame in this Community.

#### **Charter Cornerstone Donor**

A Donor that that donates \$5,000.00 or more during the first year of the Aurora Sports Hall of Fame as defined by the dates when Inductees are announced. In 2013 this date is August 28<sup>th</sup>. Donations can be pledged but must be received during the first calendar year of the Aurora Sports Hall of Fame, ending August 27<sup>th</sup>, 2014. There is presently one (1) Cornerstone Charter Donor and it is our objective to engage five (5) additional donors in this first year of operation and who will be recognized in perpetuity in the Aurora Sports Hall of Fame for their generosity in this important first year of operation. Once this first year is completed, there will be no more opportunities to become a Charter member and join this elite group of contributors. The Charter Cornerstone Donors will be recognized on a plaque that will be displayed in the Aurora Sports Hall of Fame in perpetuity. Charter Cornerstone Donors and a guest will be also invited at no cost to each Induction Celebration in perpetuity.

#### **Gold Cornerstone Donor**

A Donor that donates \$25,000 or more accumulated over the donor's giving will be recognized as Gold Cornerstone Donors once the \$25,000.00 threshold has been achieved. Gold Cornerstone Donors and a guest will be invited at no cost to each Induction Celebration once the Gold threshold has been achieved.

#### **Silver Cornerstone Donor**

Donors who provide \$15,000.00 or more over their giving cycle will be recognized as Silver Cornerstone Donor once the \$15,000.00 threshold has been achieved. Silver Cornerstone Donors will be invited at no cost to each Induction Celebration once the Silver threshold has been pledged or received.

#### **Bronze Cornerstone Donor**

A Donor that donates \$7500.00 or more over their giving cycle will be recognized as Bronze Cornerstone Donors once the \$7,500.00 threshold has been achieved. Bronze Cornerstone Donors will be invited to each Induction Celebration at no cost once the Bronze threshold has been pledged or received.

In addition All Cornerstone Donors will receive the following benefits:
