Councillor Gaertner welcomed Councillor Constable and expressed appreciation to everyone who participated in the process to fill the Council vacancy.

Councillor Constable expressed his appreciation and stated that he was looking forward to working with Council.

Mayor Dawe noted that he had received a number of e-mails regarding activity at the Highland Gate Golf Club and he advised that surveyors were on the grounds, under the authority of the Ministry of the Environment and Climate Change, to investigate a water drainage issue.

Mayor Dawe extended congratulations to the Aurora Lawn Bowling Club which recently celebrated its 100th anniversary.

Mayor Dawe advised that July 31, 2014 is the deadline to use the website **voterlookup.ca** to confirm whether eligible voters are on the voters list for the 2014 municipal election.
