#### Joanne Barnett, Vice President, Charlieville Developments Limited Re: Item 1 – HAC14-026 – Request to Remove a Property from the Aurora Register of Properties of Cultural Heritage Value or Interest; and Notice of Demolition of a Structure on a Listed Heritage Property, 45 Tyler Street (Charlieville Developments Limited)

Ms. Barnett reviewed the environmental issues of the property and advised on regulations as set out by the Ministry of the Environment. She noted that the watercourse is salvageable and the site can be remediated environmentally, however, without the demolition permit the developer has advised that he would not proceed. Ms. Barnett noted that the developer is not in a position to retrofit the building as significant portions need to be removed as part of the environmental cleanup.
