#### 1. General Committee Report No. PRCS17-012 – Music Aurora

Mayor Dawe provided a brief outline of the report and noted that the event will be called the Aurora Summer Music Festival. The Committee inquired about the fit of the event with the Canada 150 theme, diversity in music, seating, and recommended other Canada 150-themed activities that could be included in the event.

#### **Background**

This memorandum serves as an update to the Canada 150 Ad Hoc Committee on the current status of the Celebratory Tattoo. As a result of not being able to book a brass band, the Aurora Celebratory Tattoo, that was scheduled for Saturday, May 20, 2017, has been cancelled.

The Tattoo was one of the signature special events planned for this year by this Committee and was an additional event to other Canada 150 events and event enhancements planned within the existing 2017 Town of Aurora Special Events Calendar.

When funding was approved by Council, the timing was tight for making the Tattoo possible as staff had yet to contact the essential marching pipes and drum bands for the Tattoo which includes a brass band.

To date, all of the marching pipe and drum bands and key instrumental elements for creating a memorable Tattoo had been secured by staff with the exception of a brass band and without a competent brass band, a Tattoo is not possible.

#### **Background**

The Canada 150 Ad Hoc Committee had received funding from Council, of which \$40,000 was earmarked for the development and presentation of a Celebratory Tattoo. As staff have now confirmed, the Tattoo has been cancelled, and the funds are available for reconsideration by the Committee.

Staff has developed the following list of items for consideration. Once direction has been provided, staff will report back to Council for approval of the change in purpose for the approved funding.
