4. Delegations

(a) Mark Schollen, Schollen & Company Inc., representing BG Properties (Aurora) Inc. and Ballymore Homes South Aurora Re: Proposed Trails and Connections in BG Properties and Ballymore Homes Developments

Mr. Schollen presented an overview of the trails and connections within the BG and Ballymore lands, situated north of Ridge Road between Yonge Street and the Metrolinx Corridor, including site context, trail system hierarchy, elements of the Aurora Trails Master Plan, land ownership, proposed trails on public and private lands, and the Yonge Street to Metrolinx trail connections. He further reviewed the proposal for a 3.0-metre wide trail at the railway berm and three options: Option A – Ramped trail with retaining walls; Option B – Angled concrete tunnel through berm; and Option C – Concrete tunnel with ramp. Mr. Schollen noted that Option A was the preferred option.

(b) Klaus Wehrenberg, Resident Re: Trail Alignment through BG Properties Subdivision and Cattle Crawl

Mr. Wehrenberg presented history and context regarding the subject area, including the existing cattle crawl, which he noted was backfilled in the 1990's and is shown as a grade-separated railroad crossing in the Trails Master Plan. He stressed the importance of a direct trail route for cyclists and pedestrians, including students, from the cattle crawl to Yonge Street and noted that the current configuration of the BG subdivision would not facilitate a direct route. Mr. Wehrenberg suggested that the challenge of land elevations east of the cattle crawl could be managed through the use of elevators or escalators. He requested that the Committee make a recommendation to Council to reconsider the proposed trail routings, and he requested to receive a copy of any formal communication with Metrolinx regarding the cattle crawl crossing.

Recommendation

- 1. That the memorandum regarding Trailhead Parking BG Properties (Aurora) Inc. be received; and
- 2. That the Concept Plan for the Trailhead Parking Area be approved.

Background

BG Properties (Aurora) Inc. is the developer that is currently developing lands on Yonge Street south for condominium residential use. As a condition of draft plan approval the developer is obligated to provide a trail system throughout the environmental protection and open space lands that will be conveyed to the Town as well as provide trailhead parking for trail users. The development and the proposed trail system are identified on the attached Woodhaven Aurora Neighbourhood Plan.

Initially, the location of the trailhead parking was proposed on Town open space lands at the end of Cannon Valley Court with driveway access to Yonge Street via the Emergency Road Connection. However, as Yonge Street is a regional road in this area, York Region did not approve the access location due to potential traffic conflicts associated with a single use driveway access. A second trailhead parking location was proposed utilizing an existing shared use driveway from Yonge Street at the north end of this development however this location could not be utilized due to the legalities associated with an easement on the shared use driveway. Locating the trailhead parking within the development itself could not be achieved due to the fact that all roads in this development are private condominium roads.

A proposal has subsequently been provided by the developer for trailhead parking to be located on the emergency Access to Ridge Road at the south end of the development. See the attached Trailhead Parking Area Concept Plan – Option B. This concept proposes in-line parking stalls parallel to the emergency access road travel lane. The emergency access road would be conveyed to the Town and this would meet the objective of providing public access to the parking area. Some of the concerns associated with this parking concept include:


- The Town would be taking ownership of the obligation to maintain an emergency access road for a private development.
- Local residents may object to the emergency access road being used for public access and parking.
- Parallel parking adjacent an emergency access route is not ideal and would require a turn-around area.

The proposal for trailhead parking on the emergency access to Ridge Road is still conceptual and detail design would need to be worked out to the Town's satisfaction.


Attachment 1 – Woodhaven Aurora Neighbourhood Plan
