Executive Summary

The purpose of this report is to provide the semi-annual report of the allocation of funds for the Culture and Recreation Grant. The total allocation for 2019 was \$9,650.

Background

Each year Council allocates funds from the Operating Budget in support of the Culture and Recreation Grant and the John West Memorial Scholarship. This budget line includes \$14,000 for the Grant program and \$2,000 for the Scholarship.

The Community Services Department currently administers both the Grant and Scholarship programs. Applications for the grant are processed throughout the year and updates on the allocation of funds are presented to Council on a semi-annual basis.

Analysis

Allocation of funds

The Culture and Recreation Grant (including \$2,000 for the John West Memorial Scholarship Award) was allocated a total of \$16,000 for 2019.

Since the last report presented to Council (CMS19-017) in June 2019, the Town received five applications for the Culture and Recreation Grant; three were approved for funding totalling \$2,650 and two were denied funding.

The following table shows the breakdown of funds between the organizations who received funding between July and December 2019:

Optimist Club	\$1,000	To offset the cost of ice logo at the Ford Arena.	Not eligible in 2019. Organization will be eligible once again for funding in 2021.
Aurora High School - First Robotics Team	\$1,000	Raising funds to be able to participate in a Science and Technology competition	Received funding in February 2019 for \$1,000. Organization will be eligible once again for funding in 2020.

Financial Implications

Since July 2019, funds totalling \$2,650 were issued as part of the 2019 allocation. The total allocation for 2019 was \$9,650.

In 2019, \$16,000 was budgeted for the Culture and Recreation Grant program and the John West Memorial Scholarship, which includes two recipients receiving \$1,000 each, totaling \$2,000.

Of the remaining \$14,000 for the Culture and Recreation Grant, \$9,650 was allocated to eligible recipients.
